The CHHATTISGARH STATE MARKETING CORPORATION LIMITED invites tender from IRDA registered firms/parties in single bid system for procurement of General Insurance Policies for 652 CSMCL retail vending shops.

The main purpose of this tender document is to invite competitive bids from the eligible bidders to quote for General Insurance Policies.

CSMCL is a Public-Sector corporation under the CG Excise department dealing with the retail sale of all kinds of liquor/beer/wine to the consumers in Chhattisgarh. Keeping in view the nature of business of the Corporation, the following General insurance policies are generally taken by the Corporation for safeguarding its insurable interests: -

- 1. Fire Floater declaration Policy (Allied Perils Including STFI, Terrorism, And Earthquake) of Stock
- 2. Standard Fire (Allied Perils Including STFI, Terrorism, And Earthquake) of Asset
- 3. Burglary insurance of Assets and Stock
- 4. Cash insurance (Cash in safe)

Details of the expected sum to be insured for various assets of the Corporation against each policy are given in the enclosed Annexures. The tenders received after the due date and stipulated time due to any reason whatsoever including postal delay will not be considered. The Managing Director, CSMCL, Raipur, Chhattisgarh reserves the right to accept or reject any or all tenders without assigning any reason.

#### **MINIMUM ELIGIBILITY CRITERIA**

The Insurance Company must meet the following minimum eligibility criteria -

- 1. The insurance co. must be Public sector Co., registered with IRDA.
- 2. Registration details (Self- attested copies of all Certificates / Licenses / Permits / Registrations, etc., should be enclosed failing which the application is liable to be rejected outright.)
- 1. PAN NO.
- 2. Service Tax Registration No.
- 3. Company CIN No.
- 4. IRDA Regn. No

#### **BID DETAILS**

The tender is for taking insurance policies for Fire (Fire and Allied Perils Including Stfi, Terrorism and Earthquake), Burglary insurance of Assets and Stock, and Money in Safe regarding the 652 shops of CSMCL.

Fire and Burglary Insurance Policies are to cover the stock and the assets worth Rs. 400 crores(approx.) (subject to change during the policy period) at any point of time in CSMCL Shops throughout the State. The details of the 652 Liquor Shops is furnished in **APPENDIX-V**.

The above policies will be for a period of one year from 1<sup>st</sup> July 2020 to 30<sup>th</sup> June 2021.

Bidders are required to furnish their offers including all taxes etc., strictly as the prescribed in Financial Proposal. Rates should be firmed and no escalation will be allowed during the currency of contract.

#### **INSTRUCTIONS TO INSURANCE COMPANIES**

#### 1. BACKGROUND

The Chhattisgarh State Marketing Corporation Limited was established in the year 2017. It is in the business of retail sales of potable liquor made out of Extra Neutral Alcohol, Beer/Wipe across Chhattisgarh state.

The role of CSMCL is the retail sale of all kinds of liquor/beer/wine to the consumers in Chhattisgarh. Any non-availability of any item is the decision of the respective manufacturer not to sell the item in Chhattisgarh. The price at which an item is available in Chhattisgarh (as against any other places) is due to factors governing the pricing by the manufacturer and the State Excise laws.

#### 2. SCOPE OF WORK

The insurance company shall submit terms as per the Notice of tender and mention the deviations if any. The Insurer will pay to or on behalf of the Insured all Loss resulting from a Claim against the Insured except for and to the extent that the Company has indemnified the Insured. This cover only applies when the Claim is first made and reported to the Insurer during the Policy Period, or Discovery Period if applicable.

#### 3. PROPOSAL

- 3.1 The Bidder shall ensure to comply with the Tariff / Rules /Regulations /Guidelines & Insurance Policies as filed with IRDAI by the Insurer, which the Insurer shall confirm at the time of submission of the Tender.
- 3.2 Insurance companies may only submit one proposal. If an Insurance company submits or participates in more than one proposal, such proposals shall be disqualified.

#### 4. DUE DATE AND TIME

The Tender should reach the office of the Managing Director, CSMCL Limited, 4th Floor, Excise building, Labhandi, Raipur, Chhattisgarh – 492001 before 03.00 p.m. on 25.06.2020.

Tenders received after the due date and time will be summarily rejected.

#### 5. AMENDMENT TO THE TENDER CONDITIONS

- 5.1 Before the closing of the Tender, CSMCL may amend the Tender document as per requirements or wherever CSMCL feels that such amendments are absolutely necessary.
- 5.2 Amendments also may be given in response to the queries by the prospective bidders. Such amendments will be notified in the CSMCL's website.
- 5.3 CSMCL at its discretion may or may not extend the due date and time for the submission of bids on account of amendments.
- 5.4 The bidders (i.e. those who had downloaded Tender documents) must periodically browse CSMCL website <a href="https://excise.cg.nic.in/csmcl/">https://excise.cg.nic.in/csmcl/</a> till the closing date of this Tender for any amendments or corrigendum issued in connection with this Tender.
- of this Tender document on account of the bidders' failure to update the bid documents based on changes announced through the website. Provided no such changes would be affected within 72 hours prior to the time fixed for the opening of the bid documents.

#### 6. MODE OF DISPATCH

6.1 Tenders (both commercial and Price bids) should be addressed to the Managing Director, CSMCL, Excise Building, Labhandi, Raipur, by designation and should be sent only in sealed covers by "Registered Post with Acknowledgement due" or dropped in the Tender Box kept at the reception of Corporate Office.

62 Tenders received in ordinary covers without seal will be rejected.

CSMCL will not be responsible for the delay in receipt of the tenders submitted by post under any circumstances.

#### 7. TWO COVER SYSTEM

The tender should be sent in two separate sealed covers. Cover 'A' should contain commercial bid containing the details of their capability to undertake the tender. The cover `B' should contain the Price bids. Both the covers should be sent together so as to reach this office on or before the due date and time.

The commercial and Price bids which are not submitted in the prescribed format will be summarily rejected.

#### A. COMMERCIAL BIDS

The details of the company's capability to undertake the tender, the profile of the company and other particulars as prescribed in Appendix-I should be kept in the Commercial Bid - cover 'A.

#### **B. PRICE BID**

The price bid should be in the format prescribed in Appendix-II(A), III(B), II(C & D). The price bids should be quoted for policies 'Without additional Excess clause'. Bids quoted for policies 'With additional Excess clause' will be summarily rejected.

#### **8. SUPERSCRIPTION**

Both the covers cover 'A' - commercial bid and cover B' - price bid should be superscribed as "**Tender for procuring Insurance policies**". The cover 'A' (or) cover B' should also be specifically indicated on each of the covers. The covers received without such superscription will be summarily rejected.

#### 9. DETAILS TO BE FURNISHED AND MODE OF PRESENTATION.

- 9.1 The Tender should contain particulars including the name and addresses of the Tenderers, the rate of premium amount, Discount offered, Service Tax and such other levies that may be applicable.
- 9.2 The rates should be kept firm for ninety days from the date of opening of the Tender for acceptance. The tenderers cannot withdraw the offer for a minimum period of ninety days from the date of opening of Tender.
- 9.3 The rate should be quoted for each item in the specification and should be indicated clearly both in words and figures. Any scoring or overwriting should be attested by the Tenderers with full signature and seal.
- 9.4 The rate quoted should be firm and should not be subjected to any variation clauses. Conditional offers will be summarily rejected.

#### 10. OPENING OF TENDER

The cover 'A' received will be opened by the Managing Director, CSMCL Limited or any officer authorised by him on his behalf at the Corporate Office of CSMCL in the presence of such of those Tenderers or their representatives who may be present at the time of opening of the Tenders.

The representatives of the Tendering Firms who are attending the opening of the tenders should bring a letter of authority from the tendering firms which they represent to identify their bonafide.

The cover `B' will be opened at a notified date and time in the presence of the tenderers shortlisted after the evaluation of the covers 'A'.

#### 11. EVALUATION OF BIDS

#### A. Commercial bids (Cover 'A') Appendix I

CSMCL will evaluate the General & Commercial bids by adopting the criteria given below and will reject the bids of the companies which the committee feels that they are not capable to undertake the Tender and the price bids of those companies will not be opened.

The Companies securing less than 25% marks will not be qualified and their price bids will not be opened.

### B. Price Bid (Cover `B') Appendix - II

The premium rates may be quoted in the format given in Appendix -II. Price bids of the short-listed Tenderers (or all Tenderers if all of them are found eligible) will be opened at a notified date and time. Negotiations will be held only with the lowest quoted tenderer.

The L-1 will be selected based on the total premium amount quoted in respect of all the policies.

#### **INTERESTS OF INSURANCE**

# 12.FIRE (FIRE AND ALLIED PERILS INCLUDING STFI, TERRORISM, AND EARTHQUAKE) AND BURGLARY OF STOCK.(Floater Declaration Policy)

- 12.1 CSMCL proposes to ensure the Liquor and Beer stocks at these 652 retail shops (approx.), to cover the risks of STFI, Terrorism, Earthquake, and Burglary of stock.
- 12.2 The details of approximate value of stock in all these 652 retail outlets at any point in time is given at **Appendix V**. Increase/Decrease in this amount of total stock will be intimated subsequently based on the total stock actually kept in the shops and the opening of new shops. (List of Shops with sum to be insured shop wise is mentioned under Annexure V).
- 12.3 CSMCL will declare the closing stock value of CL/BEER/WINE/IFL and Scotch whiskey held at the Shops at landed cost as on last working day of the month in the first week of succeeding month. The Fire Policy, CSMCL needs is a Floater Declaration Policy.
- 12.4 Fixed asset of the corporation amounts to 25 cr. Details and the breakup of the assets are annexed here with annexure IV for 652 retail shops. These include Electrical installations, Furniture, Fixtures & Fittings, electronic equipment, Printers, CCTV cameras, all computer accessories, Solar System. Details of the electronic devices will be provided in the contract after the tender awarded to the insurance company.
- 12.5 The selected tenderer has to issue the Original Policy covering the details within 10 days from the date of receipt of order.

#### 13. MONEY IN SAFE INSURANCE POLICY

- 13.1 It has also been decided to cover the risk of Money in Safe and Cash against terrorism, SRCC & Burglary i.e. everyday sale proceeds at the CSMCL Retail Shops which will be kept in safe at the retail shops itself. Cash in counter will be Rs. 5 lakhs.
- 13.2 The sum insured will be around Rs.25.00 lakhs per Shop in case 652 shops each.
- 13.3 The selected tenderer has to issue the Original Policy covering the details within 10 days from the date of receipt of order.

#### 15. PAYMENT OF PREMIUM AND ITS ADJUSTMENT

- 15.1 In respect of Fire Insurance (Fire including STFI, Terrorism and Earthquake) (Floater Policy), premium amount for the CL/BEER/WINE/IFL (Country Liquor, Beer Wine, and Indian Made Foreign Liquor) and Scotch whisky items held at all the CSMCL retail shops throughout the State will be worked out and paid in advance at the beginning of the year in one lump sum.
- 15.2 The excess premium available with the insurance company at the end of policy period should be refunded to CSMCL within 15 days. CSMCL will declare the closing stock value at landed cost as on the last working day of the month in the first week of succeeding month.
- 15.3 In respect of Burglary of stock Insurance, premium amount for the CL/BEER/WINE/IFL (Country Liquor, Beer, Wine and Indian Made Foreign Liquor) and Scotch whisky items held at all the CSMCL shops will be worked out and paid in advance at the beginning of the year in one lump sum.
- 15.4 In respect of Money in Safe Insurance, the premium shall be worked out and paid in advance at the beginning of the year in one lump sum.

#### 16. SURVEY AND PAYMENT OF CLAIMS.

- 16.1 **Settlement of claims:** The Insurance company shall promptly make "ON ACCOUNT" payment of 50 % of the claim amount within 14 days without waiting for formalities once the claim is admitted.
- 16.2 In Case of delay in settlement of the claim amount, a penalty to the insurance company of 0.1 % of the claim amount up to the cap of 10% shall be levied per day. If in case penalty amount exceeds 10% of the claim, the tender will be forfeited.
- 16.3 **Appointment of surveyor** The insurer shall provide a panel of efficient surveyor for deployment at Raipur and outstation surveyors along with their full name, contact no., address etc. to facilitate the appointment of surveyor within 15 days of insurance claim by CSMCL.
- 16.4 **Survey Report:** The insurer shall also confirm the list of surveyors as provided by them, will submit a report within 30 days of submission of the document by CSMCL to ensure proper and prompt claim settlement.
- 16.5 **Modus operandi:** The Insurer shall provide detailed process of settlement of claims process with agreement at annexure VI. The process should be divided into three headings as (1) Coverage under the policy (2) Exclusions (if any) to be specifically mentioned and (3) Deviation (if any) from the proposal.
- 16.6 The value of stock received during a month at a landed cost will be declared within a week's time in the succeeding month.
- 16.7 The rates should be quoted "without additional Excess clause".
  The rates quoted "with the additional Excess clause" will be summarily rejected.
- 16.8 In case of insurance claims of value above Rs.5000/- whether Normal cases (or) Accident cases, the standard requisite documents will be furnished to the Insurance Company. On receipt of the documents in full shape, the company has to settle the claim within a fortnight's time.

#### 17. ACCEPTANCE AND WITHDRAWAL

- 17.1 The final acceptance of the tender is entirely vested with the Managing Director, CSMCL who reserves the right to accept or reject, any or all of the tenders without assigning any reason whatsoever. There is no obligation on the part of CSMCL to communicate with rejected Tenderers. After acceptance of the Tender by CSMCL, the Tenderer shall have no right to withdraw his Tender or claim higher rates.
- 17.2 The Managing Director reserves the right:
  - i)to reject all or any of the tenders without assigning any reason.
  - ii) to split up the tender.
  - iii) to negotiate with the tenderer before entering into the agreement.

#### 18. ACTION AGAINST THE TENDERER

Furnishing incorrect information in the Tender Documents, failure to act according to Tender conditions, non-fulfillment of any or whole of the contract may entail blacklisting of the Tenderer in addition to taking other appropriate action against the Tenderer.

#### 19.DISPUTES

- 19.1 In respect of all the tender conditions, the decision of the Managing Director, CSMCL shall be final and binding. In the event of any dispute arising out of the tender, such dispute would be subject to the jurisdiction of the Sole Arbitrator, Raipur.
- 19.2 The Sole arbitrator will be Secretary (Finance), Govt. of Chhattisgarh or representative appointed by him.

Whereas the insurance agency has offered to enter into contract with Managing Director for insurance of insurable interests as mentioned in Tender No. CSMCL/Tender /2020-21/5 Dated: \_\_\_\_\_\_ of retail shops under the jurisdiction of Managing Director, CSMC Ltd. as per terms approved by the Managing Director (copy of Rates annexed) have been duly accepted.

Now these presents witness and it is hereby agreed and declared by and between the parties to these conditions as follows:

- 2.1. General insurance policies for safeguarding its insurable interests of Corporation: -
  - 1. Fire Floater declaration Policy (Allied Perils Including STFI, Terrorism, And Earthquake) of Stock
  - 2. Standard Fire (Allied Perils Including STFI, Terrorism, And Earthquake) of Asset
  - 3. Burglary insurance of Assets and Stock
  - 4. Cash insurance (Cash in safe)
- 2.2. Fire and Burglary Insurance Policies are to cover the stock worth Rs.400 crores(approx.) (subject to change during the policy period) at any point in time in CSMCL Shops throughout the State.
- 2.3. The Insurer will pay to or on behalf of the Insured all Loss resulting from a Claim against the Insured except for and to the extent that the Company has indemnified the Insured material.
- 2.4 The Insurance company shall promptly make "ON ACCOUNT" payment of 50 % of the claim amount within 14 days without waiting for formalities once the claim is admitted.
- 2.5 In Case of delay in settlement of the claim amount, a penalty to the insurance company of 0.1 % of the claim amount up to the cap of 10%

- shall be levied per day. If in case penalty amount exceeds 10% of the claim, the tender will be forfeited.
- 2.6 Any dispute regarding the admissibility of the claims, the decision of Managing Director, CSMCL shall be final.
- 2.7 Number of Shops as well as amount insured may vary during the currency of insurance policies.
- 2.8 The Insurance company shall provide a panel of efficient surveyor for deployment at Raipur and outstation surveyors along with their full name, contact no., address etc. to facilitate the appointment of surveyor within 15 days of insurance claim by CSMCL.
- 2.9 The Insurance company shall also confirm the list of surveyors as provided by them, will submit a report within 30 days of submission of the document by CSMCL to ensure proper and prompt claim settlement.
- 2.8. The district wise list of surveyors engaged by Insurance Co. is enclosed along with this agreement.
