1. EARNEST MONEY DEPOSIT AND COST OF TENDER

1.1 Each Tender should be accompanied by Earnest Money Deposit in form of Demand Draft drawn on any Scheduled Commercial Bank Payable at Raipur in favor of the Managing Director, CSMCL, Raipur, Chhattisgarh payable at Raipur as per details given below:-

- 1.2. Tenders received without EMD and cost of tender document will be summarily rejected. Furnishing incorrect information will entail forfeiture of Earnest Money Deposit in full or part as per discretion of the Corporation. The Earnest Money Deposit of the unsuccessful Bidders will be returned after the finalization of the Tender at the expenses of the Bidders within a reasonable time. The above Earnest Money Deposit amount held by the CSMCL till it is returned to the Bidders will not earn any interest. EMD of the successful Bidders will be adjusted towards security deposit payable by it or returned by CSMCL on receipt of 100% value of Performance Security Deposit.
- 1.3. The Cost of Tender document is ₹41,300.00/- (Rupees Forty One Thousand Three Hundred Only)(inclusive of GST) submitted in form of Demand Draft drawn on any Scheduled Commercial Bank Payable at Raipur in favor of the Managing Director, CSMCL, Raipur, Chhattisgarh.

2. MINIMUM ELIGIBLITY CRITERIA

2.1. The Bidder must be a firm/agency/company that should be registered under LLP Act, 2008 or incorporated company in India under Companies Act 1956/2013 and must be in existence for the last 03 years. (Relevant Documents of registration to be submitted).

- **2.2.** The Bidder must possess independent EPF and ESI registration with competent authority which should be valid as on date of bid submission. (Self-attested copies of valid EPF & ESI registration to be enclosed).
- **2.3.** The Bidder should have provided cash pickup and delivery services /cash management services for at least, last three financial years. (Proof in form of experience certificate to be provided).
- **2.4.** The Bidder must have an average annual turnover of at least ₹100.00 Crores in past 3 financial years i.e. FY 2020-21, FY 2021-22 and FY 2022-23 (copies of Balance Sheets along with CA Certified turnover certificate to be attached).
- **2.5.** The minimum net worth of bidder should be ₹ 100 Crores in past 3 financial years i.e. FY 2020-21, FY 2021-22 and FY 2022-23(copies of Balance Sheets along with CA Certified net worth certificate to be attached). The net worth of at least ₹ 100 Crores should be maintained at all times.
- 2.6. The Bidder must have provided Cash pickup and delivery services/Cash management services of cumulative annual value of amount of ₹ 4 Crores or more to atleast 2 Central/State Government Departments/ Organizations/ Institutes/ PSUs/ Scheduled Commercial Banks/ Financial Institutions/ NBFCs/ Large Retailers/ Petrol Pumps/ Liquor Shops for at least two years out of previous three financial years i.e., FY 2020-21, 2021-22 and 2022-23. (Proof to be submitted as per Experience Certificate Format provided in Annexure XV.)
- **2.7.** The Bidder must have a fleet of 300+ cash vans, 50+ Vaults and trained manpower for maintaining and managing cash shipments as per prevailing MHA & RBI guidelines. (Self-certification along with details to be provided, for trained manpower the name of trained manpower personnel along with their EPF/ESIC no. to be provided in self-certificate, for cash vans RC/lease documents of van in favor of bidder to be provided, for vaults details of their location to be provided in self-certificate).

2.8. The Bidder will also furnish details of all these criteria while applying:

- **2.8.1.** Bidder will provide their last 3 years IT (Income Tax) Returns duly self-certified by authorized signatory of the bidder.
- **2.8.2.** Certificate of "No near relative" (as per Annexure V of the Tender Document) of the bidder to be executed on Non-Judicial Stamp paper as per requisite value under Stamp act & Attested by Public Notary/Executive Magistrate by the bidder.

- **2.8.3.** The detailed address with Telephone/Mobile, Fax and E-mail address with details of its authorized officials/Representatives of the Registered Head Office of the Bidder along with its Branches in the State of Chhattisgarh.
- **2.8.4.** Self-Attested copy of Memorandum of Association / Articles as applicable.
- **2.8.5.** Bidder must have a valid GST registration certificate issued by competent authority. (Copy of GST Registration Certificate).
- **2.8.6.** Declaration towards Non–tampering of tender document.
- **2.8.7.** Duly executed Power of Attorney/Board Resolution in favour of authorized signatory of the bidder for bid submission and signing.
- **2.8.8.** Bidder's Profile.
- **2.8.9.** Undertaking as per Annexure I of the tender document
- **2.8.10.** Bid Form as per Annexure II of the Tender Document.
- **2.8.11.** Duly executed Pre Contract Integrity pact as per Annexure IX of the Tender Document.
- **2.8.12.** Affidavit of "BLACKLISTING & NON- BLACKLISTING" of bidder to be executed on Non-Judicial Stamp paper as per requisite value under Stamp act & attested by Public Notary/Executive Magistrate by the bidder as per Annexure-XII.
- **2.8.13.** Declaration as per Annexure XIV of the Tender Document.

The offers from the Bidder which are not supported with relevant documents, as mentioned above and any form of misrepresentation made in respect of submitted documents will not be considered.

3. QUERIES ON TENDER DOCUMENT AND PRE BID MEETING

3.1. A prospective bidder requiring any clarification on the Tender Document shall notify the Corporation in writing or through email. The Corporation shall respond in writing to any request for the clarification of tender document which it receives not later than 5 days prior to the last date of submission of bid. 3.2. A Pre-bid meeting of the interested parties shall be convened at the designated date, time and place as provided in Schedule to Invitation of Tender. During the course of Pre-bid meeting, the Bidders will be free to seek clarifications and make suggestions for consideration of the CSMCL. CSMCL shall endeavour to provide clarifications and such further information as it may, in its sole discretion, consider appropriate for facilitating a fair, transparent and competitive Bidding Process. The bidders shall submit their suggestions and required clarifications to CSMCL in writing. The interested parties may be asked for small presentation for offered solutions provided by them.

4. AMENDMENT OF TENDER DOCUMENT

- **4.1.** At any time, prior to the date for submission of bids, the Corporation may, for any reason whether suo moto or in response to a clarification requested by a prospective Bidder, modify the tender document by the issuance of Addenda/Corrigenda.
- **4.2.** Any Addenda/Corrigenda issued shall be notified in website of the Corporation for information of prospective bidders.
- **4.3.** In order to afford prospective bidders a reasonable time to take the Addenda/Corrigenda into account in preparing their bids, the Corporation may, at its discretion, extend the deadline for the submission/opening of bids suitably.
- **4.4.** The bidder before submission of bid shall go through the Addenda/Corrigenda, if any, issued by the Corporation.
- **4.5.** CSMCL also reserves the right to modify or alter the Tender Document and also to withdraw or cancel the Bidding process at any stage.

5. RIGHT TO ACCEPT OR REJECT:

Corporation shall not be bound to accept the lowest or any tender and reserves to itself the right to accept or reject any bid or to accept whole or a portion of tender, as it may deem fit, without assigning any reason thereof and without incurring any liability to the affected bidder(s) for the action of Corporation.

6. MODE OF DESPATCH

Tenders should be addressed to the Managing Director, Chhattisgarh State Marketing Corporation Limited, by designation and should be submitted only in sealed covers sent by Registered post with Acknowledgement due or handed over in person. Tenders received in ordinary covers without seal will be rejected. No other modes of submitting tender will be accepted.

7. LATE BIDS

Bids received after the time specified for closing of the tender shall be rejected and returned unopened to the bidder. It is the sole responsibility of the bidder that it should ensure timely submission of bid.

8. COST OF BIDDING

The bidder shall bear all costs associated with the preparation and submission of the bid. Corporation shall in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

9. BID FORMS (TWO BID FORMAT).

- 9.1 The tender will be in two bid format namely: Technical Bid and Financial Bid. The tender should be submitted in three envelopes covers; <u>One</u> super scribing Technical Bid, <u>Second</u> Financial Bid and <u>Third</u> containing Demand Draft of Tender Fee and Earnest Money Deposit and all the above-mentioned envelopes are in turn, be put in another envelope and this envelope should be superscripted "TENDER FOR PROVIDING CASH PICKUP AND DELIVERY SERVICES FOR RETAIL LIQUOR SHOPS OF CSMCL FOR ZONE NO.___". All the three envelopes are to be duly sealed. Technical Bid and Financial Bid shall be opened separately. No indication of the Prices will be made in the Technical Bid.
- **9.2** On all these envelopes the name of the firm must be clearly mentioned and should be properly sealed.
- 9.3 Tender will be opened in the presence of Bidders present on the due date of opening i.e. 16.00 HRS on 12-04-2024. Technical Bids of the Tenders received will be opened on that day and the Sealed Financial Bids will be kept in Corporation custody. The Time, Date and Venue of the opening of FINANCIAL BIDS will be intimated only to those Bidders, whose Technical Bid is accepted after evaluation of details and documents as per tender conditions. No correspondence in this regard will be entertained. Incomplete Tender or Tender in which both Technical Bid and Financial Bid are found in the same envelope or tender with loose documents will be summarily rejected. The Bid must be submitted in spiralled booklet form only with proper indexing and page numbers.
- **9.4** The bids which are not submitted in above-mentioned manner shall be summarily rejected.

- **9.5** The bidder will be bound by all terms, conditions & specifications as detailed in the tender documents.
- **9.6** Any bid with conditions other than those specified in the tender document is liable to be summarily rejected. Conditional bids will be summarily rejected.
- **9.7** Financial Bid of the technically qualified bidders only will be opened.
- **9.8** Bidder shall furnish the requisite documents as per tender's terms and conditions.
- **9.9** Rates should be quoted in Financial Bid Form at Annexure VI. The format for Financial Bid should not be changed in any manner. Addition / deletion / alteration of the text will automatically render the tender invalid and therefore, will be summarily rejected.
- **9.10** The duly filled tenders must be accompanied with a Security deposit (Earnest Money Deposit) valid for a period of 90 days drawn on any Scheduled Commercial Bank payable at Raipur in favour of Managing Director, CSMCL, Raipur, Chhattisgarh.
- **9.11** The bidder is requested to examine all instructions, forms, terms and specification in the Bid documents. Failure to furnish all the information required as per Bid Documents or submission of the bids not substantially responsive to the Bid Documents in every respect will be at the bidder's risk and may result in rejection of the Bid.
- **9.12** The bidder shall bear all costs associated with the preparation and submission of the bid. Corporation in no case will be responsible for these costs regardless of the conduct or outcome of the bidding process.
- **9.13** The bidder shall submit, as a part of its bid, the bid documents (in original) duly sealed and signed on each and every page, establishing the conformity of its bid to the bid documents of all the works to be executed by the bidder under the contract.
- **9.14** The bids containing erasures or alterations will not be considered except as necessary to correct errors made by the bidder. Such corrections shall be signed with date by the person or persons signing the bid.
 - (Note: The bidder is advised to keep a photocopy (at his/her own cost) of the bid documents for his/her own reference)

10. BID OPENING AND EVALUATION:

Opening of Bids by the Corporation:

- 10.1 Corporation shall open the Technical bid cover containing documents in the presence of bidders or their authorized representative who wish to be present at the time of opening of bids on due date. Authorization letter to this effect shall be submitted by the bidder before they are allowed to participate in bid opening (Format is given in Annexure IV). After scrutiny and evaluation of the Technical Bids, the Corporation shall shortlist those bidders who are eligible and fulfill the eligibility conditions and furnish all documents as given in Technical Bid and the date of opening of Financial Bid will be intimated later on. The financial bid will be opened only in those cases that fulfill the eligibility conditions and furnish all documents as given in Technical Bid.
- **10.2** The bidder's representatives, who are present, shall sign on an attendance register.
- **10.3** Maximum of two (2) representatives for any bidder shall be authorized and permitted to attend the bid opening.
- **10.4** The bids shall be opened in the following manner:
 - **10.4.1.** The bid opening committee shall count the number of bids and assign serial numbers to the bids. For example, if 10 tenders have been received the bids shall be numbered as 1 of 10, 2 of 10 etc. All the members shall initial on the outer envelopes of all bids with date.
 - **10.4.2.** The envelopes containing the tender offer and not properly sealed as required shall not be opened and shall be rejected outright. Closing the cover with gum/adhesive will not be treated as sealed cover. The reasons for not opening such bidder offers shall be recorded on the face of the envelope and all the members of the opening committee shall put their initial with date.
 - **10.4.3.** First the outer envelope containing the three envelopes shall be opened. The bid opening committee shall put their initial on all three envelopes with date.
 - **10.4.4.** Among these three envelopes, the envelope marked "Bid Security and Tender Fee" shall be opened first and examined.
 - **10.4.5.** The bidders who have submitted proper EMD and tender fee as per tender document, their "TECHNICALBID" shall be opened and recorded by the Tender committee.

10.4.6. The technical bid will be evaluated by Tender Evaluation Committee. The Bidders will be declared responsive by Tender Evaluation Committee those who qualify eligibility criteria.

10.5 Technical Evaluation:

- **10.5.1.** The Tender Evaluation Committee shall evaluate the bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are generally in order.
- **10.5.2.** If there is discrepancy between words figures, the amount in words shall prevail. If the bidder does not accept the correction of the errors, its bid shall be rejected.
- **10.5.3.** Prior to the detailed evaluation, the Tender Committee will determine the substantial responsiveness of each bid to the bid document. For purpose of these clauses a substantially response bid is one which conforms to all the terms and conditions of the bid documents without deviations. The Tender Committee determination of bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence.
- **10.5.4**. A bid, determined as substantially non-responsive will be rejected by the Tender Committee and shall not subsequent to the bid opening is made responsive by the bidder by correction of the non-conformity.
- **10.5.5.** The Tender Committee may waive any minor infirmity or non-conformity or irregularity in a bid which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of the bidder.
- **10.5.6.** The financial Bid of only those Bidders will be opened who are declared technically qualified as per technical evaluation by the tender evaluation committee.
- **10.5.7.** The Financial Bid of the technically qualified bidders will be opened on specified date & time as intimated to technically qualified bidders.
- **10.5.8.** The technically qualified bidder whose rate is lowest will be declared L1 as per rates quoted in Financial Bid and will be awarded contract.

11. AWARD OF CONTRACT

- **11.1** Corporation shall consider placement of letter of intent to those L1 bidder whose offer has been found technically and financially acceptable. The bidder shall within 1 week of issue of letter of intent, give its acceptance and submit performance security in conformity with clause 16 of Section-II within 2 weeks.
- 11.2 The work will be awarded to L1 Bidder and second lowest (L2) shall be given preference to work at L1 rate in case the L1 declines to accept the work. Maximum of 2 Zones shall be awarded to a bidder. The L1 rate received among all the zones will be considered as L1 Rate. If the successful L1 bidder doesn't take work at L1 rate, the L2 bidder will be offered to work at L1 rate treating it as L1 and so on. In case no one agrees to work at L1 rate, than all eligible bidders will be offered to work at L1 rate and the bidder providing consent will be awarded work. The decision of MD, CSMCL in this regard will be final and binding on all bidders.
- **11.3** The decision of Managing Director in this regard will be final and binding on the bidders.
- 11.4 Maximum of 2 zones shall be allotted to a bidder. If a bidder is declared L1 in a zone, then the bidder shall have to accept the work allotted to that zone. If the said bidder is declared L1 bidder in subsequent zone as per sequence of zonewise bid opening then the bidder shall have to accept the work allotted to that zone also. If the same bidder has bid in other zone(s), then his/her subsequent bids shall not be considered for evaluation.
- 11.5 If sufficient number of bids is not received for Zone(s) then CSMCL may call for retender for such zone(s). As an interim measure CSMCL may call successful L1 bidders to offer their rates for such zone(s). The lowest offer received shall be awarded work of such zone(s) till the retendering process is completed.
- **11.6** The bidder shall furnish separate bank Guarantee/ EMD/ Security Deposit for working as an agency of additional zone. The entitlement of Corporation to levy penalties and for levying liquidated damages shall be separate for the additional zone allotted to the bidder/agency.

12. SIGNING OF CONTRACT

- **12.1** Signing of Agreement shall constitute the award of contract to the bidder.
- **12.2** Till the period agreement is signed, issue of work order along with tender terms and conditions will constitute as award of contract.

Upon the successful bidder furnishing the Performance Security in pursuant to provisions of clause 16 of this section, the Corporation shall discharge the EMD of the successful bidder in accordance with clause 1.2 of this section.

13. ANNULMENT OF AWARD

Failure of the successful bidder to comply with the requirement of clause 11 shall constitute sufficient ground for the annulment of the award and forfeiture of the bid security, in such a case the Corporation may award the contract to any other bidder at its discretion or call for new bids.

14. PERIOD OF VALIDITY OF BIDS

- **14.1** The bid shall remain valid for 90 days after the date of opening of bids. A bid valid for a shorter period shall be rejected by Corporation as non-responsive.
- **14.2** The Managing Director, CSMCL reserves the right to request the Lowest 3 bidders (L1, L2 & L3) to extend the bid validity for a further period of 120 days and the bidder has to necessarily extend the bid validity. Refusal to extend the bid validity will result in forfeiture of the EMD.
- **14.3** A bidder accepting the request of Corporation for an extension to the period of bid validity, in exceptional circumstances, will not be permitted to modify its BID.

15. DURATION/PERIOD OF CONTRACT

- **15.1** The work shall be valid for a period of 2 years from the date specified in the work order. Upon the expiry of the period of 2 years the Corporation may renew this contract for a further period of 1 year and in case of any special exigency, the contract may be extended for a further period of upto 12 months beyond the original renewal period of one year with mutual consent of both parties.
- **15.2** The work can be short closed if so required in CSMCL interest. The approved agency will not have any right of claim in case of short closure.

16. PERFORMANCE SECURITY

16.1 The successful bidder shall be required to deposit an amount in form of bank guarantee equivalent to 33 percent of estimated cost of tender within 2 weeks of conveying Corporation's intention for accepting the bid as Performance Security. If the accepted tenderer fails to remit the Security Deposit within in

- the above said period, the Earnest Money Deposit remitted by it will be forfeited to CSMCL and its Tender will be held void.
- **16.2** Performance Security shall be submitted in the form of Bank Guarantee for a period of at least 4 years issued by a Scheduled Commercial Bank and as per the Proforma provided in **Annexure-VII** of the tender document.
- **16.3** Performance Security will be discharged after completion of Service Provider Agency performance obligations under the contract and on expiry of the contract period subject to the satisfaction of the CSMCL.
- **16.4** If the Service Provider Agency fails or neglects any of its obligations under the contract, it shall be lawful for Corporation to forfeit either whole or any part of performance security furnished by the bidder as compensation for any loss resulting from such failure.

17. TERMINATION OF CONTRACT

- 17.1 In case of any default by the Agency and in any of the terms & conditions of the tender, Corporation may without prejudice to any other right/remedy which shall have accrued or shall accrue thereafter, terminate the contract, in whole or in part, by giving 15 days notice in writing to the Service Provider Agency.
- 17.2 All instructions, notices and communications etc. under the contract will be given in writing and if sent to the last known place of business, shall be deemed to be served on the date, even in ordinary course of post, these would have been delivered to the Service Provider.
- 17.3 Notwithstanding anything contained herein, Corporation also reserves the right to terminate the contract at any time or stage during the period of contract, by giving 15 days' notice in writing without assigning any reason and without incurring any financial liability whatsoever to the Service Provider.

18. SUSPENSION OF CONTRACT

Corporation reserves the right to suspend and reinstate execution of the whole or any part of the work without invalidating the provisions of the Contract. Orders for suspension or reinstatement of the works will be issued by the Managing Director/Authorized Representative to the agency in writing. The time for completion of the Works will be extended for a period equal to duration of the suspension. During suspension period of work, if the work of agency is executed by another agency appointed by CSMCL, the cost of such work undertaken during suspension period will be recovered from the Agency.

19. FRUSTRATION OF CONTRACT

In the event there is frustration of the Contract because of supervening impossibility in terms of Section 56 of the Indian Contract Act, then the parties shall be absolved of their responsibility to perform the balance portion of the Contract.

20. TERMINATION FOR INSOLVENCY

Corporation may at any time terminate the contract by giving written notice and without compensation to the Service Provider Firm terminate the contract, if the Service Provider becomes unwilling, bankrupt or otherwise insolvent as declared by the competent court. Provided that such termination will not prejudice or affect any right or action or remedy which has accrued or will accrue thereafter to the Corporation.

21. ASSIGNMENT AND SUB-LETTING OF CONTRACT

The Agency shall not assign, sublet or subcontract any part of the Contract under any circumstances, whatsoever. Further, any such Assignment/ Subletting/ Subcontracting, as above shall be void ab initio and the Corporation will take necessary actions against the Agency for such violation.

22. INSURANCE

The Service Provider shall arrange necessary insurance cover for any persons deployed/cash handled/cash in transit/cash vans, etc. Corporation shall not entertain any claim arising out of mishap, if any, that may take place. In the event of any liability/claim falling on Corporation, the same shall be reimbursed /indemnified by the Service Provider. The insurance claim will be responsibility of the service provider and CSMCL will not be responsible for any disputes in insurance claims.

23. FORCE MAJEURE

If any time, during the currency of this contract, on the occurrence of any unforeseen event, beyond the control of either Party, directly interfering with the delivery of Services, the performance in whole or in part by either party of any obligation under this contract shall be prevented or delayed by reason of war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosion, epidemics, quarantine restrictions, strikes, lockouts, or act of god

(herein after referred to as events), the affected Party shall, within a week from the commencement thereof, notify the same in writing to the other Party with reasonable evidence thereof.

Provided that, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any such claim for damages against the other in respect of such non-performance and work under the contract shall be resumed as soon as practicable after such event may come up to an end or cease to exist and the decision of the Corporation as to whether the work have been so resumed or not shall be final and conclusive.

Provided further that if the performance, in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceedingly 60 days either party may, at its option terminate the contract.

24. SET OFF (RECOVERY OF SUM DUE):

- **24.1.** Any sum of money due and payable to the Service Provider (including security deposit refundable to it) under this contract may be appropriated by Corporation and set off the same against any claim of Corporation for payment of a sum of money arising out of this contract or under any other contract made by Service Provider with Corporation.
- **24.2.** In the event of said security deposit being insufficient, the balance of total amount recoverable, as the case may be shall be deducted from any sum due to the Service Provider under this or any other contract with The Managing Director, CSMCL, Raipur, Chhattisgarh. Should this amount be insufficient to cover the said full amount recoverable, the Service Provider shall pay to The Managing Director, CSMCL, Raipur, Chhattisgarh, on demand the balance amount, if any, due to The Managing Director, CSMCL, Raipur, Chhattisgarh within 30 days of the demand by Corporation.
- **24.3.** If any amount due to the Corporation is so set off against the said security deposit, the Service Provider shall have to make good of the said amount so set off to bring the security deposit to the original value immediately by not later than 10 days.

25. JURISDICTION AND LEGAL PROCEEDINGS

The Agency, if it initiates any legal proceedings against the Corporation with respect of enforcement of its right as per this tender, the jurisdiction to initiate such proceedings shall be the place where the Corporation Head Office is located i.e. Raipur, Chhattisgarh, India and not where the Agency has its registered office. Any matter or issues arising under this tender or any dispute hereunder shall be subject to the exclusive jurisdiction of the courts situated at Raipur, Chhattisgarh, India and/or courts exercising jurisdiction over Raipur, Chhattisgarh, India.

26. ARBITRATION

- **26.1.** The parties shall try to resolve disputes amicably between them, in case of failure of the parties to do so the dispute shall be referred for arbitration as per this clause.
- **26.2.** Any dispute arising from or associated with this contract shall be referred to arbitration for resolution. The arbitration shall be conducted as per the provisions of Indian Arbitration and Conciliation Act 1996.
- **26.3.** The seat and venue of the arbitration shall be Raipur, Chhattisgarh, India.

27. CORRUPT OR FRAUDULENT PRACTICES.

- **27.1.** The Tendering Authority requires that the Bidders/Contractors under this tender observe the highest standards of ethics during the procurement and execution of such contracts. In pursuance of this policy, "THE TENDERING AUTHORITY" defines for the purposes of this provision, the terms set forth as follows:
 - a) "corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of the public official in the procurement process or in contract execution; and
 - b) "fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or an execution of a contract to the detriment of the Tendering Authority, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Tendering Authority of the benefits of the free and open competition;

SECTION III

SCOPE OF WORK

- 1.1. Chhattisgarh State Marketing Corporation Ltd. is engaged in retail Sale of Liquor in the State of Chhattisgarh. The Corporation expects a total annual sale of ₹16000 Crores during FY 2024-25 and the sale will come from 672 shops (pickup points) located in 33 Excise Districts of State of Chhattisgarh. The list of Shops located in 33 Excise Districts is enclosed in Annexure-XI.
- **1.2.** The agency shall provide services of picking up cash from all the Retail Outlets/Pickup Points of CSMCL and for depositing at Bank Account of particular Retail Outlet.
- 1.3. The cash pickup and delivery of the cash in bank accounts is to be done with utmost security and the cash transit should be carried out in armoured vehicles/cash vans which should be monitored through a GPS tracking system. The cash vans should be guarded by armed security personnel and should be equipped with speed jammers and geo-fencing devices for utmost security. The cash pickup and deposition activity along with security measures is to be performed strictly as per prevailing guidelines/norms issued by MHA/RBI.
- **1.4.** The agency has to provide details and credentials of vehicles, cash pickup and deposition personnel and gunman deployed to the Concerned District Head of CSMCL as well as CSMCL Head Office. Any, change in the vehicle, cash pickup and deposition personnel and gunman can be only done with the prior authorization and approval of CSMCL.
- may be allotted Cash Chest if required, by CSMCL, in such cases the agency will be responsible for all the costs related to the Cash Chest installation. The agency will have to pay monthly Rent of ₹ 2000/- (excluding applicable taxes) per chest if allotted to it by CSMCL. The rent charged will be deducted from the dues of Agency. The agency will also be responsible for proper maintenance and upkeep of Cash Chests allotted to it by CSMCL.
- **1.6.** The agency will be required to get the cash insured during transit as per amount being pickup from shop. The agency will be solely liable for the insured cash.

- **1.7.** The cash is to be picked up from all the pick-up locations on day to day basis on all days of the month and should be deposited in Bank latest by 2.30 p.m. by next bank working day i.e. by T+ 1 day (where T= Date of cash pickup).
- **1.8.** The Negative difference between cash pickup from shop and that deposited in bank will be recovered from the agency as per cash shortage report.
- **1.9.** In the event of cash shortage or loss of entire cash due to any theft, robbery in transit or such other unforeseen circumstances after pickup of cash by agency, the same is to be deposited and credited to CSMCL account within 3 days time limit by the agency without fail from the date of issue of such demand by CSMCL.
- **1.10.** The amount pickup will be updated in CSMCL Server by the Agency at the time of cash pickup at the shop.
- **1.11.** CSMCL will issue requisite form for subsequent addition of pickup points or authorized personnel and issue instruction(s) through written order as per the convenience of CSMCL.
- **1.12.** Under no circumstances, the cash picked up should be handed over to any individual. It should be only deposited in the bank account of CSMCL.
- **1.13.** The Agency has to provide day-wise, month-wise details of cash pickup, cash deposited and cash-in-hand/vault of agency as per format and manner prescribed and issued by CSMCL.
- **1.14.** MD CSMCL reserves the right to issue necessary instructions from time to time for cash pickup and deposition process as per convenience and needs of CSMCL.
- **1.15.** The cash pickup and deposition process is as mentioned below:

Cash Pick-up Process

- **I.** The process of Cash pick-ups shall be applicable for 100% cash available at retail outlets of CSMCL.
- **II.** CSMCL shall merge all the cash (of all denomination available including coins) into bundles and prepare the summary slip for entire cash to be picked up.
- **III.** The service provider should process the entire cash/coin available and should be counted and then pickup in sealed bags. The agency will arrange cash counting machine required for counting of cash.

- **IV.** It will be the responsibility of the agency to check for any soiled notes/Fake Indian Currency Notes (FICN) at the time of pickup. Once the cash has been pickup, CSMCL will not be liable for any soiled notes/FICN later on.
- **V.** The pickup personnel of Agency will use RFID card issued by CSMCL to enter Cash pickup details from shop in CSMCL server at the time of cash pickup and upload the same in CSMCL Server.
- **VI.** One copy of pickup slip will be handed over to the concerned shop/pickup location personnel of CSMCL and one copy to CSMCL District office while the agency shall retain one copy for its own.
- **VII.** The agency will keep record of the cash pickup and will produce the cash pickup report as and when desired by CSMCL or any agency authorized by CSMCL.

Cash Deposit Process

- **I.** Agency shall deposit the all the cash picked up in the mapped bank branches along with summary slip and triplicate Cash deposit slip.
- **II.** Agency shall retain one copy of bank acknowledgement deposit slip & hand over the other acknowledgement copy to CSMCL District Office.

SECTION IV

SPECIAL CONDITIONS

1. PENALTY CLAUSE

- **a.** The agency has to mandatorily pickup cash from each shop on all days of the year except dry days and days on which shops remain close and deposit the cash picked up. In case the cash is not picked up/deposited as per terms and condition on any day from any shop/bank, the agency will have to pay a penalty @ 18% per annum of the amount not pickup /deposited as per delay in pickup/deposit and also for the difference in the cash picked up and deposited if any.
- **b.** The breach of any laws and the breach of any of the covenants of this contract shall entitle the corporation to impose a penalty equivalent to 10% of the total contract value on the collection agency as liquidated damages. The levy of such damages shall not be disputed and the entitlement of the corporation to levy such damages shall be during the currency of the contract or settlement of accounts with the Agency whichever is later.
- **c.** The formula for imposing Penalty as per clause a will be as mentioned below:

Penalty for non-pickup/deposition of Cash (for every single instance) =(Amount of cash not pickup/deposited X No. of days of delay X 18 percent)/365

2. PAYMENT TERMS

- **a.** The agency shall prepare monthly bills in triplicate and submit on or before 10th of each month for services provided in previous month. Agency shall be responsible to submit the bills, which are prepared accurately, and giving all details to facilitate early payment.
- **b.** The detailed MIS of shops in which cash pickup is done in the concerned month is to be enclosed along with Bill.
- **c.** The details of pickup in shops on daily basis and details of deposit in bank with proof.
- **d.** Penalty will be imposed for delay in cash pickup and deposit.
- **e.** The Agency has to submit a joint cash pickup and deposit certificate signed by concerned District head of CSMCL and internal auditor of the concerned

district/shop and concerned manpower agency certifying that the pickup cash of the month has been 100 percent deposited in the bank account of CSMCL.

f. The Cash Pickup and Deposition Fee will be paid on monthly basis after completion of month and the firm submitting its bill for the same.

PRE-CONTRACT INTEGRITY PACT

(To be submitted on non-Judicial Stamp Paper of value in accordance with provisions of Stamp Act)

1.GENERAL

1.1. This pre-bid contract Agreement (herein after called the Integrity Pact) is made
onday of the month 20 between, CSMCL acting through
CSMCL) (hereinafter called the "BUYER", which expression shall mean and include,
unless the context otherwise requires, his successors in the office and assigns) and
the First Party, proposes to procure (name of the Stores/Equipment/Work/Service)
and M/s represented by
the "BIDDER/Seller", which expression shall mean and include, unless the context
otherwise requires, his successors and permitted assigns) and the Second Party, is
willing to offer/ has offered.

1.2. WHEREAS the BIDDER is a Private Company/Public Company/ Government Undertaking/ Partnership/Registered Export Agency, constituted in accordance with the relevant law in the matter and the BUYER is a Corporation of the Government, performing its function on behalf of the Government of Chhattisgarh.

2. OBJECTIVES

NOW, THEREFORE, the BUYER and the BIDDER agree to enter into this pre-contract agreement, hereinafter referred to as Integrity Pact, to avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the Contract to be entered into with a view to: -

- **2.1.** Enabling the BUYER to obtain the desired Stores/Equipment/Work/Service at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and
- **2.2.** Enabling BIDDERs to abstain from bribing or indulging in any corrupt practices in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing any corrupt practices and the BUYER will commit to prevent corruption, in ay form, by its official by following transparent procedures.

3. COMMITMENTS OF THE BUYER

The BUYER commits itself to the following: -

3.1. The BUYER undertakes that no official of the BUYER, connected directly or indirectly with the contract, will demand, take promise for or accept, directly or

through intermediaries, any bribe, consideration, gift, reward, favor or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the contract.

- **3.2.** The BUYER will, during the pre-contract stage, treat BIDDERs alike, and will provide to all BIDDERs the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to the other BIDDERs.
- **3.3.** All the officials of the BUYER will report the appropriate Government office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such a breach.

In case any such preceding misconduct on the part of such official(s) is reported by the BIDDER to the BUYER with the full and verifiable facts and the same prima fade found to be correct by the BUYER, necessary disciplinary proceedings, or any other action as deemed, fit, including criminal proceedings may be initiated by the BUYER and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the BUYER the proceedings under the contract would not be stalled.

4. COMMITMENTS OF BIDDERS

The BIDDER commits itself to take all measures necessary to prevent corrupt practices, unfair means an illegal activity during any stage of its bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commit itself to the following: -

- **4.1.** The BIDDER will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the BUYER, connected directly or indirectly with the biding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the contract.
- **4.2.** The BIDDER further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favor, any material or immaterial benefit or other advantage, commission, fees, brokerage, or inducement to any official of the BUYER or otherwise in procuring the Contract of forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other contract with the Government for showing or forbearing to show favor or disfavor to any person in relation to the contract or any other contract with the Government.
- **4.3.** The BIDDER further confirms and declares to the BUYER that the BIDDER in the original Manufacture/Integrator/ Service Provider Authorized government

sponsored export entity of the stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the BUYER or any of its functionaries, whether officially or unofficially to the award of the contract to the BIDDER, nor has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation or recommendation.

- **4.4.** The BIDDER, either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payment he has made, is committed to or intends to make to officials of the BUYER or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.
- **4.5.** The BIDDER will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.
- **4.6.** The BIDDER will not accept any advantage in exchange for any corrupt practice, unfair means and illegal activities.
- **4.7.** The BIDDER shall not use improperly, for purpose of competition or personal gain, or pass on to others, any information provided by the BUYER as part of the business relationship, regarding plans, technical proposal and business details, including information contained in any electronic data carrier. The BIDDER also undertakes to exercise due and adequate care lest any such information is divulged.
- **4.8.** The BIDDER commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.
- **4.9.** The BIDDER shall not instigate or cause to instigate any third person to commit any of the acts mentioned above.

5. PREVIOUS TRANSGRESSION

- **5.1.** The BIDDER declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public-Sector Enterprise in India/Chhattisgarh or any Government Department in India/Chhattisgarh that could justify BIDDER's exclusion from the tender process.
- **5.2.** If the BIDDER makes incorrect statement on this subject, BIDDER can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason.

6.EARNEST MONEY & SECURITY DEPOSIT

6.1. Every BIDDER while submitting commercial bid, shall deposit an amount as specified in RFP as Earnest Money/Security Deposit, with the BUYER through any of the following instruments:

- (i) Earnest Money deposit through Bank Draft in favor of Managing Director CSMCL, RAIPUR payable at RAIPUR
- (ii) Security Deposit in form of Bank as per Clauses of tender document
- **6.2.** The Earnest Money/Security Deposit shall be valid up to a period of five years or the complete conclusion of the contractual obligations to the complete satisfaction of both the BIDDER and BUYER, including warranty period, whichever is later.
- **6.3.** In the case of successful BIDDER, a clause would also be incorporated in the Article pertaining to Performance Bond in the Purchase Contract that the provisions of Sanctions for violation shall be applicable for forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
- **6.4.** No interest shall be payable by the BUYER to the BIDDER on Earnest Money/Security Deposit for the period of its currency.

7. SANCTIONS FOR VIOLATIONS

- **7.1.** Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the BUYER to take all or any one of the following actions, wherever required: -
- (i) To immediately call off the pre-contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with the other BIDDER(s) would continue.
- (ii) To forfeit fully or partially the Earnest Money Deposit (in pre-contract stage) and/or Security Deposit/Performance Bond (after the contract is signed), as decided by the BUYER and the BUYER shall not be required to assign any reason therefore.
- (iii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER.
- (iv) To recover all sums already paid by the BUYER, and in case of the Indian BIDDER with interest thereon at 2% higher than the prevailing Prime Lending Rate while in case of a BIDDER from a country other than India with interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to the BIDDER from the BUYER in connection with any other contract such outstanding payment could also be utilized to recover the aforesaid sum and interest.
- (v) To encash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the BUYER, along with interest.
- (vi) To cancel all or any other contracts with the BIDDER and the BIDDER shall be liable to pay compensation for any loss or damage to the BUYER resulting from such cancellation/rescission and the BUYER shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.

- (vii) To debar the BIDDER from participating in future bidding processes of the Government of Chhattisgarh for a minimum period of five years, which may be further extended at the discretion of the BUYER.
- (viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middlemen or agent or broken with a view to securing the contract.
- (ix) In cases where irrevocable Letters of Credit have been received in respect of any contract signed by the BUYER with the BIDDER, the same shall not be opened.
- (x) If the BIDDER or any employee of the BIDDER or any person acting on behalf of the BIDDER, either directly or indirectly, is closely related to any of the officers of the BUYER, or alternatively, if any close relative of an officer of the BUYER has financial interest/stake in the BIDDER's firm, the same shall be disclosed by the BIDDER at the time of filling of tender. Any failure to disclose the interest involved shall entitle the BUYER to rescind the contract without payment of any compensation to the BIDDER.

The term 'close relative' for this purpose would mean spouse whether residing with the Government servant or not, but not include a spouse separated from the Government servant by a decree or order of a competent court; son or daughter or step son or step daughter and wholly dependent upon Government servant, but does not include a child or step child who is no longer in any way dependent upon the Government servant or of whose custody the Government servant has been deprived of by or under any law; any other person related, whether by blood or marriage, to the Government servant or to the Government servant's wife or husband and wholly dependent upon Government servant.

(xi)The BIDDER shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee of the BUYER, and if he does so, the BUYER shall be entitled forthwith to rescind the contract and all other contracts with the BIDDER. The BIDDER shall be liable to pay compensation for any loss or damage to the BUYER resulting from such rescission and the BUYER shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.

7.2. The decision of the BUYER to the effect that a breach of the provisions of this pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the Monitor(s) appointed for the purposes of this Pact.

8. <u>INDEPENDENT MONITORS</u>

- **8.1.** The BUYER will appoint Independent Monitors (hereinafter referred to as Monitors) for this Pact.
- **8.2.** The task of the Monitors shall be to review independently and objectively, whether and to what extent the parties comply with the obligations under this Pact.

- **8.3.** The Monitors shall not be subject to instructions by the representatives of the parties and perform their functions neutrally and independently.
- **8.4.** Both the parties accept that the Monitors have the right to access all the documents relating to the project/procurement, including minutes of meetings. The Monitor shall be under contractual obligation to treat the information and documents of the BIDDER/Subcontractor(s) with confidentiality.
- **8.5.** As soon as the Monitor notices, or has reason to believe, a violation of this Pact, he will so inform the Authority designated by the BUYER.
- **8.6.** The Monitor will submit a written report to the designated Authority of BUYER/Manager in the Corporation/within 8 to 10 weeks from the date of reference or intimation to him by the BUYER/BIDDER and, should the occasion arise, submit proposals for correcting problematic situations.

9. FACILITATION OF INVESTIGATION

In case of any allegation of violation of any provisions of this Pact or payment of commission, the BUYER or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information of the relevant documents and shall extend all possible help for the purpose of such examination.

10. LAW AND PLACE OF JURISDICTION

This Pact is subject to Indian Law, the place of performance and jurisdiction shall be the seat and venue at Raipur, Chhattisgarh.

11. OTHER LEGAL ACTIONS

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the any other law in force relating to any civil or criminal proceedings.

12. VALIDITY

- **12.1.** The validity of this Integrity Pact shall be from the date of its signing and extend up to 5 years or the complete execution of the contract to the satisfaction of both the BUYER and the BIDDER/Seller whichever is later. In case BIDDER is unsuccessful, this Integrity Pact shall expire after six months from the date of the signing of the contract.
- **12.2.** If one or several provisions of this Pact turn out to be invalid; the remainder of this Pact shall remain valid. In such case, the parties will strive to come to an agreement to their original intentions.
